18. RADIO STATIONS



A. PRIVATE RADIO STATIONS

For **news** radio stations 1,5%, on their total gross income per year, with a minimum guarantee /per year:

- pan Cyprian coverage €2.000
- local coverage €1.500

For **music** radio stations 3,8%, on their total gross income per year, with a minimum guarantee /per year:

- pan Cyprian coverage €5.000
- local coverage €3.000

For **entertainment** radio stations 3,8%, on their total gross income per year, with a minimum guarantee /per year:

- pan Cyprian coverage €3.000
- local coverage €2.000

B. PUBLIC AND MUNICIPAL RADIO STATIONS

1% on their income from subscriptions, contributions and/or subsidies and 2,4% on their advertising income per, with a minimum guarantee per year, €4.000 per station

19. TV STATIONS



1. For sound recordings:

A. PRIVATE TV STATIONS

1% on their total gross income per year, with a minimum guarantee /per year €20.000

B. PUBLIC AND MUNICIPAL TV STATIONS

1% on their income from subscriptions, contributions and/or subsidies and 1,5% on their advertising income per, with a minimum guarantee per year, €15.000 per station

C. PROVIDERS OF RADIO AND TV PROGRAMS/SERVICES

1% on their total gross income per year, with a minimum guarantee /per year €20.000

2. For videoclips:

- 4% on their total gross income per year, for TV stations that use videoclips for up to 8 hours per day, with a minimum guarantee per year €20.000

- 10% on their total gross income per year, for TV stations that use videoclips for over 8 hours per day, with a minimum guarantee per year €30.000

20. DUBBING (reproduction for the sole purpose of public performance/ communication to the public)

Reproduction of sound recordings and/or videoclips for the sole purpose of public performance/communication to the public (up to 5000 sound recordings per year with the possibility of up to 200 track updates every month, per area/establishment)

20% on the total gross income per year, with a minimum fee 30€ for sound recordings and 100€ for video clips per year per area/establishment



21. SIMULCASTING

- For **news** radio stations 1,5% on their total gross income per year, with a minimum guarantee 500€ per year.
- For **music** radio stations 3,8% on their total gross income per year, with a minimum guarantee 700€ per year.
- For **entertainment** radio stations 3,8% on their total gross income per year, with a minimum guarantee 600€ per year.



22. NON INTERACTIVE WEBCASTING

A. Annual fee for the communication to the public as follows:

Up to 20 separate streams	45
Up to 30 separate streams	40
Up to 40 separate streams	35
41 separate streams and over	30



B. Annual fee for the reproduction:

Additional 2,5% on the respective fee of the above section (A).
